APPLICATION PROCESS

- <u>STEP 1</u> See a College Advisor or visit the college website (<u>www.gatewaycc.edu</u>) or the program website (<u>https://www.gatewaycc.edu/physical-therapist-assisting</u>)
 - a. Receive a program information and application packet
- <u>STEP 2</u> Read the entire packet carefully a. Contact a college advisor to discuss questions
- **<u>STEP 3</u>** Complete the Student Information Form to the College
 - a. Obtain form at the Admissions and Records office or at: <u>https://www.gatewaycc.edu/enrollment</u>
 - b. Submit form to Admissions and Records or enroll online.
- **STEP 4** Transcripts Request official transcripts from colleges/universities to be sent to the Admissions and Records Office, GWCC, 108 N. 40th St., Phoenix, AZ 85034.
 - a. Official transcripts must be sent from institution to institution. Allow 2-4 weeks for receipt. Please request the institution to include the current name and student ID number used at GateWay Community College.
- <u>STEP 5</u> Complete pre-requisites (see page 12). Review points system for admission to the program on page 9. See page 18-19 regarding the required work/observation experience. Pages 19-21 should be submitted to the Admissions and Records by the clinical site where the work/observation experience occurred upon completion of the experience.
- <u>STEP 6</u> Submit the <u>COMPLETED</u> application (page 23 and page 24) to the Admissions and Records Department. See the Selective Annual Admissions Process on page 9 for the application periods for the hybrid weekend program and the day program.

- 1. Official college/university transcripts received by GWCC Admissions and Records.
- 2. Completed Student Information Form submitted to Admissions and Records
- 3. Documentation of completion of ENG101 or ENG102 and BIO160 or BIO201 with a 3.0 GPA and a minimum grade of B in each course.
- 4. Documentation of HESI PTA Program scores with 70% or higher on each section within the last 2 years.
- 5. Completed verification of work experience/observation of 40 hrs. (SEE PAGES 19-21)
- 6. Completed application to program (**SEE PAGE 23 and 24**)

FREQUENTLY ASKED QUESTIONS ABOUT CAREERS IN PHYSICAL THERAPY

What is Physical Therapy?

Physical therapy (PT) is the art and science of providing care to patients suffering from injury or disease which has resulted in a loss of motion in the joints of the body, a loss of strength in muscles, increased pain, an inability to walk normally, as well any of several other examples of losses of physical function. Through physical therapy, patients work to regain the ability to function at their highest possible level. Patients may include infants, children, adults, and the elderly.

Who provides Physical Therapy?

Physical therapists (PTs) assess patients, determine what treatment is necessary, and perform skilled treatments. Physical therapists' assistants (PTAs) help the physical therapist by performing selected treatment interventions with patients. PTAs are always supervised by PTs.

I really want to become a physical therapist – do I need to become a physical therapist assistant first?

Individuals interested in becoming physical therapists do not need to complete education as a PTA to become a PT.

What Education is Necessary?

Individuals interested in becoming physical therapists complete a bachelor's degree prior to making an application to enter an educational program. Programs for the education of physical therapists are at the doctoral level and generally take three years to complete.

Physical therapist assistants attend community or technical colleges that offer an associate's degree. Programs can be completed in 3-5 semesters.

Where do PTs and PTAs work?

PTs and PTAs are employed in hospitals, skilled nursing facilities, schools, home health and outpatient practice settings.

How much money do PTs and PTAs make?

What is the current job market for PTAs?

The United States Department of Labor/Bureau of Labor Statistics states, "Overall employment of physical therapist assistants and aides is projected to grow 26 percent from 2018 to 2028, much faster than the average for all occupations. Demand for physical therapy is expected to increase in response to the healthcare needs of an older population and individuals with chronic conditions, such as diabetes and obesity." Graduates of the PTA Program at GateWay Community College are currently in high demand.

Why should I consider a career in physical therapy?

A career in physical therapy is very rewarding. Each day physical therapists and physical therapist assistants work closely with their patients to help them recover from injuries or illnesses that have temporarily or permanently changed their lives. PTs and PTAs are important members of the rehabilitation team. Helping people to progress back towards optimal health is a wonderful experience.

PTs and PTAs work in hospitals, rehabilitation centers, home health, schools, skilled nursing facilities, outpatient clinics and sports medicine centers. Work hours are generally during the daytime, Monday through Friday. Weekend work is generally available or required at hospitals and skilled nursing facilities.

PTs and PTAs are men and women who enjoy challenging work, communicating with people, and working in a team to assist patients to achieve their fullest rehabilitation potential.

Do I need to pass an examination to be a PT or PTA?

To hold the title of physical therapist or physical therapist assistant in Arizona an individual must pass the National Physical Therapy Examination (NPTE) for the respective level of education and training. The examination is administered by the Federation of State Boards of Physical Therapy (FSBPT). Costs associated with applying for licensure/certification and taking the examination are approximately \$650.

If I have a criminal record, will that prohibit me from being successful in this career?

Clinical agreements with healthcare facilities require that students possess a Level 1 Fingerprint Clearance Card issued by the Arizona Department of Public Safety. Additionally, a student must not be listed on the Federal Government's Office of the Inspector General's Exclusion List. Students that are unable to obtain either of these clearances will be prohibited from attending all healthcare education programs at GateWay Community College.

FREQUENTLY ASKED QUESTIONS ABOUT THE PROGRAM

How many students are admitted to the program?

A new class of 24 students is admitted each August to the traditional day program. The weekend/hybrid education program admits a new class of 20 students in May of each year. The number of students admitted may change depending on employment market conditions and the availability of clinical training sites.

What do I need to do to apply to the program?

It is recommended that interested students contact a college advisor to discuss the program (602-286-8600 or healthcareadvising@gatewaycc.edu). PTA faculty are also frequently available for consultation. Following these initial meetings, students should then work to complete the following:

- a) BIO160 (or BIO201) minimum grade of B required
- b) ENG101 or ENG102 minimum grade of B required
- c) HESI Exam PTA Program within last 2 years- minimum 70% on all sections
- d) 40 hours of work/observation experience in physical therapy with a minimum of 10 hours in an inpatient (hospital, skilled nursing care, etc.) facility. Interested applicants are encouraged to allow adequate time to complete this requirement. It may take some time to locate a site, establish a schedule, and complete the required hours.

The above requirements **MUST** be completed prior to applying to the program. A grade point average of 3.0 for BIO160/201 and ENG101/ENG102 must be achieved to be admitted into the program with a minimum grade of B in each course.

What happens to my application if I am not accepted into the program?

The prospective applicant will need to reapply for admission into the program during the next application cycle.

How long does it take to complete the program?

The day program can be completed in five semesters. Students admitted to the day program in August 2023 will graduate in May 2025, if all lecture, laboratory, and clinical courses are completed satisfactorily. Students admitted to the weekend/hybrid education program in May 2024 will graduate in September 2025, if all lecture, laboratory, and clinical courses are completed satisfactorily. Many students take a year prior to beginning program courses to complete program prerequisites and general education courses that are required for the Associate in Applied Science (AAS) degree.

Are the PTA Program courses transferable to colleges or universities if I decide to pursue a bachelor's degree?

Certain bachelor's degree programs will accept up to 90 credits from the program. Contact college advising (602-286-8600) for further information.

When are the classes scheduled?

For the day program, lecture and lab classes may be scheduled Monday through Friday. Classes may begin as early as 7:00 a.m. and end as late as 5:30 p.m. Depending on the semester, students may be in class for 3-6 hours per day, 3-4 days per week. For the weekend/hybrid education program lecture courses will be online with periodic on campus testing. Lab classes will be scheduled Friday (11:00-5:00 PM, mornings may be used for testing, review, etc.) and Saturday and Sunday, 7:30 a.m. to 5:00 or 5:30 p.m. All the lab classes are held on site at GateWay Community College. There are approximately 20 weekends of required on campus attendance for lab classes in the hybrid program.

Clinical practicum classes (PTA206, 280, and 290) for both the traditional day program and the hybrid weekend programs are Monday through Friday for eight (8) hours each day for six consecutive weeks. Extended hours and weekends are occasionally necessary during clinical experiences. These classes require attendance at clinical facilities that include hospitals, extended care facilities, and outpatient practices.

What facilities do I contact to complete my volunteer/work experience?

Applicants are encouraged to contact local hospitals, nursing homes, and private physical therapy offices to arrange for observation experience. The program requires that 40 hours of observation or work experience must be completed prior to entering the program. A minimum of 10 hours must be completed at an inpatient (hospital, skilled nursing care, etc.) facility. For volunteer experiences, this requirement will often involve observing physical therapy practice without any direct patient interaction. Receiving physical therapy for a personal injury or medical condition will not be considered as part of the observation experience requirement.

Can I work and go to school?

For the day and hybrid/weekend education programs, applicants are cautioned that the PTA Program is a rigorous course of study. The program faculty recommends that work hours be kept to a minimum. Each student must make an individual decision about the number of work hours that he/she can accept while continuing to make acceptable academic progress in the program.

Is financial aid available?

Financial assistance is available to eligible students in the form of grants, scholarships, employment, or loans. Students may receive aid from one funding source or aid may be offered in a package from multiple sources. Does the weekend/hybrid education program have special requirements?

Students in the weekend/hybrid education program will need regular access to a computer with internet capabilities (high speed service is preferred). Students must be computer literate and must be able to access documents that are presented in Microsoft Word and PowerPoint. Windows Media Player, or similar software, is also required. Students will be traveling to GateWay on alternating weekends and thus reliable motor vehicle transportation is essential. Students in this education program who travel from a distance will need to make their own lodging arrangements for the weekend lab classes. Every effort will be made to place students in their local communities for clinical education rotations. If this is not possible students may be required to drive many miles to the nearest available clinical site. Please note that only students who are considered residents of Arizona are eligible to take online classes in the weekend/hybrid program. Contact the Admissions and Records office regarding residency requirements.

Once I start the program, can I transfer from the hybrid program to the day program or from the day program to the hybrid program?

Requests to transfer from one program to the other will be considered on a case-by-case basis. Transfer may not be possible due to a variety of reasons.

PHYSICAL THERAPIST ASSISTANT SELECTIVE ANNUAL ADMISSION PROCESS

Applicants for the Physical Therapist Assistant Program at GateWay Community College will be ranked on a pointbased system. The criteria listed below will be used in the ranking process. Applicants for the program will be selected based on the points earned.

Applications for the hybrid weekend program will be accepted from July 1 through September 30. Applicants will be notified of their status by November 15. Late applications may be considered for admission if additional spaces remain in the program after the initial acceptance process has been completed. The hybrid weekend program starts in mid-May.

Applications for the day program will be accepted from December 1 through March 1. Applicants will be notified of their status by May 1. Late applications may be considered for admission if additional spaces remain in the program after the initial acceptance process is completed. The traditional day program starts in mid-August.

Any applicant that is not accepted but remains interested in the program will be required to reapply for admission during the next application period.

- 1. Grade in BIO160 or BIO201 must earn 2 points in this category and taken within the past 10 years
 - a. A = 4 points
 - b. B = 2 points
 - c. C, D or F = application will not be considered
- 2. Grade in ENG101 or ENG102 must earn 1 point in this category
 - a. A = 2 points
 - b. B = 1 points
 - c. C, D or F = application will not be considered
- 3. Score on HESI for PTA Program within the last 2 years- must earn 21 points in this category
 - a. 10% of the score in each category is added as points
 - i. i.e. score 89.5% on math = 8.95 points, 70.1% on English composition= 7.01 points, and 75.3% on anatomy and physiology= 7.53 points.
 - b. HESI scores below 70% = application may be considered.
- 4. Work or observation experience in physical therapy submit required verification form(s) must earn 1 point from this category. (10 hours of work/observation experience must be from an inpatient facility)
 - a. Work experience as a physical therapy aide/technician 2080+ hours = 3 points
 - b. Work experience as a physical therapy aide/technician 1040 to 2079 hours = 2 points
 - c. 40 or more hours of observation experience in a physical therapy practice OR 40-1039 hours of work experience as a physical therapy aide/technician = 1 point
- 5. Completion of general education requirements (ENG102, MAT, COM, HCC146 or HCC 145, PSY101, Humanities, CRE) with a minimum grade of C in each course.
 - a. 7 courses completed = 3 points
 - b. 3-6 courses completed = 2 points
 - c. 1-2 courses completed = 1 point
- 6. Work/volunteer recommendation rating
 - a. Cumulative average of 9.5 to 10 = 3 points
 - b. Cumulative average of 8.5 to 9.49 = 2 points
 - c. Cumulative average of 7.5 to 8.49 = 1 point
 - d. Cumulative average of 0 to 7.49 = 0 points
- 7. AA degree or higher 1 point
- 8. Medical credential with AA degree or higher in the field of study 1 point

IMMUNIZATIONS, TESTING, AND BACKGROUND REQUIREMENTS

IMMUNIZATION AND TB TESTING REQUIREMENTS

All health and safety documentation are submitted digitally. The health and safety requirements are subject to change based on the requirements of our clinical partners. Once a student has been accepted into a program for the start of an upcoming semester, clinical requirements will be sent out.

MCCCD BACKGROUND CHECK POLICY REQUIREMENTS

Students seeking admission to an MCCCD Allied Health or Nursing Program (Program) will be required to obtain a valid Level-One Arizona Department of Public Safety Fingerprint Clearance Card (FCC Card) AND a passing score on an MCCCD background check. This policy precludes MCCCD faculty or staff from assigning students to a clinical experience who cannot meet the new requirements.

Upon admission to the program, students are required to present a copy of the DPS card and apply for the MCCCD Background Check. Students bear the financial costs for both the MCCCD Background Check and the AZ Fingerprint Clearance Card. Students will receive Information regarding the MCCCD Background Check after admission, but prior to the beginning of the program.

Students are encouraged to apply for the card early in the application process. Please allow a minimum of eight weeks processing time for the DPS Level-One Fingerprint Clearance card. The card is valid for six years from the date of issue.

DRUG SCREENING

Each student must go through a preclinical drug screen prior to beginning the first clinical rotation. Drug screening for all Physical Therapist Assisting students is mandatory. The cost for tests will be the responsibility of the student. The urine drug screen will test for alcoholic beverages; illegal drugs, or drugs that may impair judgment while in the clinical agency. If the drug test is positive for the illegal drugs or undocumented prescription drugs, the student will not be able to continue in the program. Readmission is at the discretion of the college and the program. Some clinical sites also require screening for nicotine. Students who test positive for nicotine are allowed to continue in the program but may be limited to clinical agencies that do not test for nicotine.

ESTIMATED PROGRAM COSTS

The estimated cost for the program is outlined in the chart below. The student is responsible for providing transportation, housing, and uniforms.

- ** According to Arizona Revised Statute, 15-1802 F, "A person who is a member of an Indian tribe recognized by the US Department of the Interior whose reservation land lies in this state and extends into another state and who is a resident of the reservation is entitled to classification as an in-state student." Therefore, unclassified, and out of state surcharges do not apply to such students.

Students must also plan on the expense of driving to clinical locations across the metropolitan Phoenix and outlying areas. Several clinical affiliates are not on bus routes so one's own private transportation vehicle is necessary.

- ¹ Tuition and course fees are set by the Maricopa County Community College District Governing Board and are subject to change without notice. All other fees are also subject to change. All tuition and fees are the responsibility of the student. The calculated tuition is based on the maximum number of credits required for the AA degree.

ESSENTIAL FUNCTIONS

The following is a list of physical/mental requirements that are expected of students in the Physical Therapist Assistant Program.

- 1. Demonstrate visual acuity and auditory ability to assess the condition of a patient and administer effective patient care.
- 2. Demonstrate manual dexterity, eye-hand coordination, fine and gross motor skills, and tactile abilities to perform functions as directed by the physical therapist and in accordance with skills outlined in section three of the Evaluative Criteria for the Accreditation of Physical Therapist Assistant Education Programs (see attachment).
- 3. Demonstrate critical thinking and problem-solving skills for effective patient management and implementation of selected treatment interventions.
- 4. Maneuver equipment in a patient's room or in the physical therapy department in a time efficient manner.
- 5. Work in stressful situations that require quick thinking and the simultaneous coordination of a variety of activities.
- 6. Demonstrate physical agility to respond to patient and family needs, including unexpected changes in the patient's status.
- 7. Demonstrate the physical ability to assist patients in ambulating, positioning in bed, and transferring from the bed/mat, wheelchair, or car in a time efficient manner.
- 8. Demonstrate proper body mechanics for lifting.
- 9. Lift objects more than 100 pounds with assistance with frequent lifting and/or carrying objects weighing 50 pounds or more.
- 10. Tolerate prolonged standing, stooping, squatting, bending, pushing, and pulling.
- 11. Demonstrate ability to read, write, understand, and speak English.
- 12. Demonstrate effective verbal and non-verbal communication skills with internal and external customers.

Students who are unable to perform these functions, with or without reasonable accommodations, may be unsafe in the clinical environment and thus will likely be unsuccessful in the program.

WORK / OBSERVATION HOURS

Forty (40) hours of work/observation in physical therapy practice settings are a prerequisite to application for admission into the PTA Program. A minimum of 10 hours in an inpatient (hospital, skilled nursing facility, rehabilitation hospital) setting is required. The work/observation experience requirement has a two-fold purpose. First, it assures that the applicant has completed career exploration in the field. The applicant should be aware of the job duties and responsibilities of the PTA through the work/observation and thus be able to make an intelligent decision about the appropriateness of pursuing this career goal. Second, the program wants to be reasonably certain that students entering the program are committed to this career goal. The work/observation requirement is used to assure that applicants have had first-hand experience with the job duties that a PTA is required to perform. The applicant should expect that most facilities only allow volunteers to observe physical therapy practice. "Hands on" experience is not allowed in most facilities.

Work/observation hours can be gained at several facilities which provide physical therapy services. These facilities include acute care hospitals, skilled nursing units/facilities, rehabilitation units/hospitals, private practices, business owned practices, schools, and private agencies.

It is the responsibility of the student to arrange for work/observation hours or to certify work experience gained in the field. Work/observation can be arranged by contacting the physical therapy departments of the types of facilities noted above. Phone numbers and locations of facilities may be found in the Yellow Pages under the headings "Hospitals," "Physical Therapy," and "Nursing Homes." Facilities may have a waiting list for individuals wanting to complete observation hours and may have limited hours in which observation hours can be accommodated. Applicants often achieve the required observation hours through attendance at multiple facilities. It is common to contact several facilities before observation can be arranged. Some orientation may be required. Allow several weeks to find a facility or

facilities to complete the 40 hours. Receiving physical therapy services for a personal injury or medical condition does not count toward the work/observation hour requirement.

The work/observation hours must be certified by a physical therapist or a physical therapist assistant. Please see the Work/Observation Hours Verification and Assessment Form included in this packet. One form is required from each facility at which work/observation experience was completed.

Overview of the Requirements

In order for students to be admitted to or maintain enrollment in good standing in Maricopa County Community College District's ("MCCCD") Allied Health and Nursing programs ("Programs"), students must provide with their application to a Program all of the following:

- A copy of an Arizona Department of Public Safety Level-One Fingerprint Clearance Card ("Card"). Students are required to pay the cost of applying for the Card. Cards that are NOT Level-One status will not be accepted.
- An original version of the "Criminal Background Check Disclosure Acknowledgement" form attached to this Summary signed by the student.

At all times during enrollment in a Program, students must obtain and maintain BOTH a valid Level-One Fingerprint Clearance Card and passing disposition on supplemental background check performed by MCCCD authorized vendor. Implementation of the Requirements

All allied health and nursing students who seek to enroll in MCCCD healthcare programs must complete a Criminal Background Check. The outlined criteria have been created based on MCCCD's largest clinical experience hospital partners. These partners have stringent background check standards that preclude MCCCD from assigning students to their sites who cannot meet those standards. In order for MCCCD students to be able to continue to complete clinical experiences at local hospitals, students must meet these standards.

For persons wishing to enroll in a Program the person must meet the following standards:

- Possession of a valid Arizona Department of Public Safety Level One Fingerprint Clearance Card. Students who currently possess a DPS Card that is another level will not be allowed entrance into a health care program. Students are required to pay the cost of obtaining this background check. If the Level-One Fingerprint Clearance Card is revoked or suspended at any time during the admission process or while enrolled in a MCCCD healthcare program a student must notify the Program Director immediately and he or she will be removed from the Program. Please see the "Frequently Asked Questions" sheet for details regarding the DPS Card.
- Each student must provide documentation that he or she has completed and "passed" a MCCCDsupplemental background check through the approved vendor **American DataBank**. Students are required to pay the cost of obtaining this background check. Students whose background checks are more than six months old on the date of beginning a healthcare program must obtain an updated background check. Students who have been in a Program for more than 12 months may be requested to obtain an updated background check. Please see the attached "Frequently Asked Questions" sheet for more details regarding the MCCCD supplemental-background check.
- The MCCCD supplemental or the clinical agency background check may include but are not limited to the following:
 - o Nationwide Federal Healthcare Fraud and Abuse Databases
 - Social Security Verification
 - Residency History
 - Arizona Statewide Criminal Records
 - o Nationwide Criminal Database
 - Nationwide Sexual Offender Registry
 - o Homeland Security Search
- By virtue of the MCCCD supplemental background check, students will be disqualified for admission to a program or continued enrollment in a program based on their criminal offenses, the inability to verify their Social Security number, or their being listed in an exclusionary database of a Federal Agency or on a sex offender registry. Offenses that will lead to a "fail" on the supplemental background check may include but are not limited to:
 - Social Security Search-Social Security number does not belong to applicant
 - Any inclusion on any registered sex offender database
 - o Any inclusion on any of the Federal exclusion lists or Homeland Security watch list
 - Any conviction of Felony no matter what the age of the conviction
 - o Any warrant in any state

- o Any misdemeanor conviction for the following-No matter age of crime
 - violent crimes
 - sex crime of any kind including non consensual sexual crimes and sexual assault
 - murder, attempted murder
 - abduction
 - assault
 - robbery
 - arson
 - extortion
- o Any misdemeanor controlled substance conviction last 7 years
- Any other misdemeanor convictions within last 3 years
- Exceptions: Any misdemeanor traffic (DUI is not considered Traffic)
- At all times students are in a program they must maintain BOTH a valid Level-One Fingerprint Clearance Card and passing disposition on the MCCCD supplemental background check performed by the MCCCDauthorized vendor.
- Admission requirements related to background checks are subject to change without notice.
- Some clinical agencies may require additional components of a criminal background check, other than those required by MCCCD, as well as a drug screening. Students are required to pay for any and all criminal background checks and drug screens required by a clinical agency to which they are assigned
- Even though a student possesses a valid DPS Level One Fingerprint Clearance Card and has passed the MCCCD supplemental background check, a clinical agency may decline to place a student due to information the clinical agency obtains in a background check it requires.
- If a clinical agency to which a student has been assigned does not accept the student based on his or her criminal background check, the student may not be able to complete the program.
- MCCCD may, within its discretion, disclose to a clinical agency that a student has been rejected by another clinical agency.
- MCCCD has no obligation to make attempts to place a student when the reasons for lack of placement are criminal background check issues. Since clinical agency assignments are critical requirements for completion of the program, inability to complete required clinical experience due to a student's criminal background check will result in removal from the program.
